

#### A Letter from our Executive Director Joshua A. Hanson



Dear Friends,

This past year, 2022, was a year of exciting transitions at The Safe Center. Our long-time Executive Director Cindy Scott retired after 25 years at the helm of The Safe Center and before that the Coalition Against Child Abuse & Neglect. I had the distinct pleasure of working alongside Cindy over the last five years and feel grateful and humbled to succeed her in the executive director role.

Cindy's legacy of leadership and innovation established The Safe Center as a state and national leader among victim service agencies. True to form, her transition away from the agency was planful and reflective of her dedication to our clients, staff, and partners. Throughout 2022, she met with me and my successor Associate Executive Director, Debbie Lyons, to ensure that the leadership handoff was a smooth one. This helped establish Debbie and I on solid footing as we begin 2023.

Our work is to honor and build on Cindy's legacy, creating an even more collaborative and integrated agency that will continue to innovate and develop comprehensive services and programs. Critical to the future of the agency is developing and diversifying funding streams. A chief component of this is the launch of The Safe Center's Mental Health Clinic with Article 31 licensure. Article 31 licensure through the NYS Office of Mental Health will allow the agency to bill third-party insurance, opening an additional funding stream previously unavailable. Resulting in significant growth of our mental health services. We will also retain grant-funded mental health services to ensure that we retain the flexibility to meet the varied needs of our community.

I am very proud of the work of the agency and want to highlight how The Safe Center's Education & Learning Department is continuing to grow and evolve. In the coming year, we will work to develop more technical training offerings for professionals and community members. The department is currently in the process of reviewing all the agency's "101" trainings to ensure that they incorporate the most current information and reflect a deeper understanding of the intersectionality inherent in interpersonal violence.

We are grateful to you, our funders and friends, for your support through this transition and as we move into a bright future. You are an integral part of our work, and we could not do it without you.

In 2022 we responded to more than 6,000 hotline calls and served 4,349 clients. Our programs and services continue to serve as a beacon of hope for our community. We are pleased to share highlights from each of our specialized teams.

**Children's Mental Health Services** 



 86% of Children's Mental Health clients who were assessed demonstrated a reduction in trauma symptoms, a decreased sense of isolation and improved coping skills.

88% of parents/caregivers receiving ongoing services demonstrated an increased understanding of the impact of abuse on their child, increased emotional support of their child and improved communication with child.





Nine families were housed with the Emergency Housing Voucher thereby diverting their need to be paired with a Rapid Re-Housing Program.

17 households were served by the Rapid Re-Housing Program.

25 individuals secured employment with support from our vocational specialist.

## **Education & Training**



Educators conducted 1,331 trainings in our community attended by 42,319 people.

We have 30 dedicated volunteers providing Child Abuse Prevention trainings.


## Did you know?

Unlike other Child Advocacy Centers most of our Multi-**Disciplinary Team partners** are located on site at The Safe Center to provide a comprehensive and collaborative response. Children and families get the benefit of having both the investigative partners and the service providers working together and able to provide immediate support.

The Nassau County Child Advocacy Center at The Safe Center served over 900 children in 2022.

**Advocacy & Case Management** 



More than 185 survivors were referred to the Adult Victim Advocacy Program.

A new position of Rape & Sexual Assault Case Manager was created to provide wraparound case management services to adult survivors of rape & sexual assault who are navigating multiple systems or have chronic needs.

Our hospital advocates provided support to over 140 survivors in Nassau County's emergency rooms throughout 2022.

Did you know? Our SAFER (Survivor Advocate for Emergeny Response) responds to all emergency rooms in Nassau County.

Legal Services

Our Legal Department provided services to 237 clients.

176 clients received court advocacy services.

Human Trafficking Services

This team provided services to 107 clients.

#### Did you know?

When Nassau County Police respond to a domestic violence call, they will let the victim know that the report is shared with us. Then our hotline team will call them to introduce our agency and available services, making us not only reactive but proactive.

#### Did you know?

The Safe Center has a Trauma-Informed Care Department dedicated to ensuring that we are always evaluating our practices to be trauma-informed and help staff prevent and minimize vicarious trauma.

Rape & Sexual Assault Services

We expanded our service profile to include two art therapists.

66 Art Therapy assists survivors of sexual assault by tapping into the non-verbal traumatic memory through visual means of communication. Through art projections, survivors are able to have physical representations of their inner child and disowned parts to witness, hold, and transform. -Janine Sadowski, LCSW-R, CASAC


